ADE-1317 Certificate: Adults between ages (18-24) must have successfully completed an Adult 6-Hour course, then have taken the completed Adult 6-Hour certificate to DPS to receive their learner license (permit). Adults 25 years old and older are not required to take the Adult 6-Hour course, but may want to if attempting to receive a permit as a substitute for taking the Road Rules and Road Signs tests at the DPS. The Control Number in the top right corner must NOT be empty.

Restriction A Note: If you have a restriction 'A' on your permit or license, this typically indicates that the driver is required to wear corrective lenses (glasses or contact lenses) while operating a motor vehicle. This is a legal requirement based on vision test results, ensuring that the driver maintains adequate eyesight for safety. For your road test, you must have on your corrective lenses.

NOTE: If you have completed a Teen Drivers Ed Course in the past two years, then it is still valid even as an adult up until age 20. For example, if you completed a Teen Drivers Ed Course when you were 17, you may still use that certification for a road test within that two year completion date. You will be required to complete the ITTD Certificate for the 2-hour Impact Texas Teen Drivers Online Program and NOT the adult. Print the certificate after completion (expires 90 days from issuance). As an adult, you will NOT be required to have the 30 hour drive log.

Vehicle Requirements: If you choose to use your own car, be sure to verify every requirement, as these will be checked at the time of your test and may disqualify you from your road test. You may add the use of an AC Driving school car for \$25 through the student portal.

1. **Insurance on a PAPER copy.** Check the expiration date and make sure the vehicle being used is listed.
2. **Unexpired registration sticker** on the windshield.
3. **All turn Signals MUST be working.**
4. **All brake lights MUST be working.**
5. **2 license plates.** These plates MUST be registered in Texas.
6. **Headlights MUST be both working** if the test is being taken during dim lighting.
7. **Horn MUST be working.**
8. **Windshield wipers MUST be working** if there is a chance of rain.
9. **Side mirrors and rear view mirror** must be present.
10. **Seat belts MUST be present.**
11. **Door handles MUST work from the inside.**
